The 2022 Jesup and Camden Instructional Site's Practical Nursing cohorts have taken and passed the NCLEX exams.

GALIS Report #AE095, WIOA Table 4, displays the WIOA local totals of the number of students enrolled, total attendance hours, MSG, separated, remaining, and percentages by entering educational functioning level for all POPs (Periods of Participation) for FY23 in Adult Education (AE):

- Total Enrolled Students Educational Functioning ESL Levels 1-5: 46
- Total Number of Students Enrolled for both ABE & ESL: 545
- Total Hours of Attendance both ABE & ESL students: 27,992.25

Office of Institutional Effectiveness - Vince Jackson

The Substantive Change document for National Center for Construction Education and Research (NCCER) Carpentry Fundamentals Technical Certificate of Credit (TCC) is complete. The TCC was approved by the State Board March 2 and the sub-change document has been submitted to SACSCOC for a Fall semester 2024 implementation.

There are no new updates on the CDL truck production progress. The last report indicated delivery sometime during the third quarter of 2023. The College has been given written assurance that the grant will be honored even if the delivery falls outside of this fiscal year (2 years in process). CPTC has been asked to contact USDA in August with an update on the delivery timeline.

Office of Police & Security – Bradley Barrett

Bradley Barrett, CPTC Police Lieutenant, presented on behalf of Ethan Johnson.
