Currently, nine positions are posted for Heavy Equipment Operators within the Coastal Pines Technical College service delivery area. Of the nine posted positions, six of those state that the company is seeking multiple candidates. The Southern Pines College and Career Academy and its supporting high school partners have expressed interest in this program to meet the demand of the area. The U.S. Bureau of Labor Statistics published that the median pay for Construction Equipment Operators is \$49,290 and expects the number of positions available in 2021 to be 466,900. The job outlook is for position openings to increase by 5% annually through 2031. Training on an actual piece of heavy equipment will provide real hands-on training on the safe operation and maintenance of the equipment. This will be of great value to the businesses in the communities that the College serves.
