## **APPROVAL OF MINUTES**

Upon a motion to approve by Dialo Cartwright, a second by Summer Stipe, minutes of the February 15, 2024, CPTC Local Board of Directors' meeting were unanimously approved.

# CABINET REPORTS (Full reports uploaded to Dropbox seven (7) days prior to meeting.) Office of Economic Development – Dr. Pete Snell

The new forklift trailer has been delivered. The addition of the forklift trailer will give the College the opportunity to provide OSHA Forklift Operator training at remote locations such as the four state prisons that are located within the service delivery area. During FY25, this training will be part of a

monthly (Aug-May) rotation of training at each prison that comprises OSHA 10, ServSafe Food Handler, and OSHA Forklift Operator. It will also be used to deliver remote training for Career Ready, Adult Education, and others.

### Office of Academic Affairs - Amanda Morris

The following revised CPTC procedures have been reviewed and approved by the Cabinet and College Council:

• CPTC Procedure: Sare Driver Procedure for Commercial Truck Driving Program

The Nurse Aide program had 16 dual enrollment students graduate from Wayne County High School and all 16 have passed the state board licensure test. Bacon County High School had eight dual enrollment students graduate with all eight having passed the skills portion of the state board licensure test. However, only seven of the eight students have passed the written portion of the test.

The Practical Nursing students in the Waycross Campus (Day) and the Jesup Instructional Site cohorts have achieved a 100% pass rate on the NCLEX-PN exams. In addition, the Paramedicine program's 2023 cohort has achieved a 100% pass rate on the National Board Exams.

The Welding program held the 2nd Annual Weld-off competition January 18 on the Jesup Instructional Site. Welding used this opportunity to showcase the newly remodeled Welding Lab. Employers from RYAM, Sierra, Steel and Metal Works, and Lincoln Electric were on-site to interview and advise students on their next step in entering the workforce. The results of the competition were as follows (These winning students will be representing CPTC at the SkillsUSA state competition in Atlanta in March):

#### Office of Institutional Effectiveness – Vince Jackson

The Mechatronics Specialist (AM11), NCCER Plumber's Assistant (BP11), and Basic Avionics Technician (BAT1) programs have all been submitted to the SACSCOC substantive change portal and are currently in the queue for Board of Trustee Review.

The College's FY2024 Perkins budget has been amended and approved by TCSG. With this year's carryover funds of \$53,355.00, the total budget is \$811,861.00. The College will be purchasing a Skidsteer and several head attachments for the Basic Heavy Equipment program in Baxley with the carryover funds and residuals from other budget items.

# Office of Police & Security – Ethan Johnson

All pertinent local agencies have been notified of the Clery crime information the College needs for AY 2023. Several agencies have already responded with their statistics.

The CPTC Campus Police Department is currently in the process of migrating all of the College's fire and security systems away from landlines to cellular dialers.

As of March 8, the College has 3,837 students registered for Spring Semester. Enrollment for Spring 2023 was 3,452. Traditional enrollment consists of 1,642 students or 43% while dual enrollment consists

of 2,195 students or 57%. B-term began March 12 and a few more tradition enrollment students will be added.
