

## Clinical Obligations

Upon acceptance into the program, students will undergo a criminal background check and drug screening process to satisfy clinical affiliate requirements. Students enrolled in clinical courses complete clinical duties 2-3 days a week utilizing day shift, evening, and weekend clinical assignments. Adequate transportation is required. All students enrolled in an allied healthcare program participating in clinical rotations will incur a student charge for liability insurance.
